**General Assembly:** Approximately 21 members gathered to go over the Proposed Policy Draft that was included in the April, 2017 minutes. We made some changes, so that when the final draft is provided, it will go out for final approval by the groups. Our consensus was to make a proposal today, to adopt the revised Policy with the recommended changes as follows:

-Change Secretary budget from \$150-\$50.

-Change Secretary responsibility for General Assembly over to Vice-Chair, or designee responsibility. -Change gas reimbursement for both RD and ALT. RD to remove \$.40/ mile, and replace to reimburse for gas receipts.

-Under voting membership, reword "voting members of the region will be elected by the RCM's, to voting members of the Region will be the RCM's.

-Change addendum B (NRSC Timeline) to reflect 2-year terms for RD & Alt. RD -Correct formatting of addendum C (NRSC Budget) and reflect new budget amount for secretary. I will get these changes made to the document, and provided to the secretary, if there is consensus to proceed to forward to the groups for a final vote. Thank you for letting me serve, Diane K.

Thank you for the opportunity to do this proposal for the NRCNA Convention. Our "Bid Proposal" highlights what our property can offer and we would very much like to serve your group and would be able to offer the meeting space at no charge. We are excited about our new addition which offers some very nice amenities, an additional two great meeting/ social areas and indoor "green space", as well as a spa, plus 38 additional rooms. I have included the proposal for year 2019. Guest rooms are \$91.00 per night plus 10.5% tax (5.5% state and 5% lodging taxes). We are also doing 3 complimentary rooms for up to 3 nights each. Hospitality Room is being furnished at no charge and all meeting space is complimentary. No down payment is required and there is no criteria to be met regarding meeting room night totals. In 2014 your group booked 62 rooms for an average of 2 nights each. I did increase the room count to 72. The rooms do "fall off" or become available to the general public after September 19, 2019. Until that time they are reserved specifically for your group. We will do the first 9 gallons of coffee complimentary. After that, the cost is \$22. Per gallon for coffee. Providing space for merchandising is not an issue. It looks like we may have used the Nebraska Room for auction items when you were here in 2014. On the Conference Center side, you will be billed for food and beverage only. I do not believe there are any hidden charges. If there is an additional component or something that you would like to see as part of your event, please let me know. We do have the large firepit in the tent that is great for gather around, plus two outdoor fireplaces that work for cooking Smores. If you have any questions, please feel free to call.
