Thank you so so much for getting the word out. We were told some members were hesitant to come to our last Club/NRCNA fundraiser because we used the money to buy baby blue's. The CWC has never purchased baby blues. The CWC business committee's primary interest is in serving its members; not judging or interfering in others group's conscience. We support region and all other Areas. The club has established meeting's under one roof for many years. We are careful to try & keep our 19 meetings going as many members & newcomers have voiced enjoying the easy access to many loving NA meetings. Thank you for your prayers & we ask for your support; they are mutual; All our Love from the CWC.

Proposal # 1 Yes

Proposal # 2 No – also there was group discussion of the responsibility if Nebraska ever took any established NA meetings off our lists. For the miserable burden & horrendous guilt by our Nebraska fellowship; if an addict died wanting a meeting and was in the area where our service committee abolished those established meetings from our Nebraska list? For example many times we have truck drivers stop in wanting a meeting. We have spoken to other areas & members whom do not attend our region meetings whom have the same concerns and experiences of the importance of our newcomers and our out of towners knowing where all our established meetings are in their area? This proposal severely hinders our primary purpose. Also have the groups utilizing or giving free literature been asked about their Home group's group conscience in this matter? All members value our 2nd tradition.

Living a God centered loving spiritual We/NA program; where members are not supposed to be told what meetings they are allowed or not allowed to attend is not represented by proposal # 2. It appears to be unintentionally judgmental & demeaning to other loving members in our Nebraska fellowship by our Nebraska service group? We love & respect our region member's time of commitment & caring service work. Nevertheless maybe this could be re-evaluated? Per our CWC group discussion, we felt we should encourage establishing more meetings in our surrounding towns; following traditions; & keep them on our region meetings list to support our primary purpose.

**ENNA:** Hello family, a lot has happened since I last attended. As mentioned in my last report, the Multi-Zonal Service Symposium was such a huge success. There continues to be lasting effects on this Area and around the Region. So much was gained from this event. The ENNA PR Committee, as well as other members from the Lincoln area, have met with the Nebraska Department of Corrections. Doors are literally opening to more and more facilities. We were asked to bring a meeting into the Sarpy County Jail. We had never been allowed there before now. The 2019 Close Encounters Convention was also a huge success. 946 registered addicts were in attendance. The Committee reported that working with this hotel was a great experience.

The hotel complimented us on how well we presented ourselves. It sounds like we did a great job representing Narcotics Anonymous. Yay us! Moving to this venue, however, has more than doubled our expenses. A request for an additional \$2,000.00 start up amount for the 2020 committee was made. The 2020 CECK Committee plans on blocking more rooms at the hotel. The best way to do this is to fill a block then ask for more. They are requesting that you book your room as soon as possible.

Our Area approved the funds for a billboard in the Omaha area. We are pretty excited about this.

The proposal regarding the non-NA approved literature opened the floor for much discussion. Since I was not part of the discussion at Region, I asked for input from the more seasoned members. I feel their input was valuable and that the GSRs were able to return to their groups with good information regarding this. Looking forward to a fun-filled summer in NA. In loving Service, Diana B.

**-Received an ENNA PR report from Mark B:** Good afternoon everyone, Things in Eastern are on FIRE! We currently have 8 H&I meetings and we will soon be starting a 9th at one of our local mental health units. We also have a 10th meeting in the works for the Sarpy Co. jail which should be kicking off within the next couple of months. Activity on our phone line seems to be down quite a bit but we are recording more hits on our website recently. We just attribute this to more people using technology and moving away from simple phone calls. Project Primary Purpose sent out a total of 604 Basic Texts in 2018 and so far in 2019 a total of 191. P3 has a campout planned for Sept. 13-15 at Arrowhead Park in Neola, IA., about 15 miles east of Omaha. On the very near horizon is also a billboard project. We have already approved the funding at the area level and will probably be moving forward with the project in May.

So as many of you know and some attended, we hosted the Multi Zonal Service Symposium here in Omaha back in November. We had a couple of staff members from the Neb. Department of Corrections attend. As a result they went back and passed our information to their bosses who in turn passed it onto their boss, Scott Frakes the Director of the Nebraska Dept. of Corrections. This is where it gets really exciting. Dir. Frakes asked several of his Deputy Directors and Wardens to meet with us, ask what we needed and to make whatever that was happen. Jennifer G., Herman P., Barry B., Amanda M. and I sat down with them a couple weeks ago and it was amazing.

The topics we covered were lateral access to the prisons. Basically if you are approved at one prison you should be approved at all prisons. THEY AGREED! Lateral training was next so you can be trained in any prison and don't have to drive across the state. THEY AGREED! Then we discussed Sponsorship Behind The Walls. THEY AGREED! Along with Project Primary Purpose they will add both flyers into a blast that goes out to all the inmates tablets. Then we went into streaming speakers from our conventions, CECK and NRCNA. THEY AGREED! They have gone above and beyond to get us in.

Now is where I say we need help all across the state. We currently have meetings in progress at the Omaha Correctional Center, Neb. Correctional Center for Women (York), Neb. State Penitentiary (Lincoln), Neb. Youth Correctional Center (Omaha) and Tecumseh State Correctional Institution. We need volunteers for all these facilities. ### **General Discussion (Open Floor 3:52 PM):**

- Columbus has 2 new meetings 3602 16th Street, Methodist Outreach Center in Columbus, NE. Things are going well. - Brent D.
- If you have donations that you would like to donate to the NRCNA 36 raffle, please contact Tara N.
- Since we have passed Proposal #2, we need to identify which of these that should be removed. I have not seen any baby blues at the noon meeting at the CWC or the Friday night meeting. I don't know if there is a particular meeting at the CWC that are using the baby blues or other meetings in other communities however, these need to be identified.
- A discussion was held concerning the approval of Proposal #2. Several points were brought to the table and are as follows:

Brian S. stated, "I think it would be up to the Area's or group's to notify their RCM, and the RCM to notify the Region of these groups so, the group can be removed from the meeting list; that it may not affect the rest of the groups that meet in that Area. Norfolk has some. Their Area would have to identify these."

Tara N. stated, "Now that we have an idea of where we stand on this issue. Can we make something set in stone for the RCM or attending member? For instance, maybe in the next 3 months, to put together a list of meetings that are continuing to utilize illicit literature. The third Wed 6:30 PM Closed Men's Meeting - Clean Way Club (CWC) did ask to be removed from the list."

Brent D. from Columbus stated, "The Thursday meeting is brand new meeting. I have never heard of it since I lived in Columbus. When I was attending the CWC, seeing illicit literature was a regular thing. I go once a week at the CWC but, since I've gone, I haven't seen very much illicit literature. There has been several times. We may need to do more research to see if the literature is at just one meeting, several, or where this is coming from. We have not had a chance to fine tune the Policy for this to enforce it."

Seth R.: "Since we are talking about Norfolk, is this when we should bring up one of the meetings, Mon/Tues/Wed/Thurs Grateful Wake Up Group in Norfolk. The 2nd meeting on the list, uses illicit literature."

Kendra D: "I really think that we need a policy in place that lists how we are going to handle a situation like this. We are going to have conflicting personalities and situations etc. Having this in place will help future members of our service body, to deal with a situation that arises.

Dawn B: "We have notified a group several times that they needed to remove the illicit literature. They have not done this and we will not be going back to speak to them anymore."

Donald P: "I think we need to form a Ad Hoc to go through the details of a policy to have this put in place."

Diana B: "I think that we need to put guidelines in place for members, to not approach groups alone because, it can get really ugly."

Brian S: "We could use zoom to put together this Ad Hoc meeting; that way we are not taking a year to get this situation resolved. I would like to see our Region do a Regional Zoom Meeting so, anyone can attend. I do like to partake in the new technology we have, to make this available to people who may not be able to be physically present. We have two accounts at the PSZF to utilize this stuff. Why can't we utilize this to form and Ad Hoc committee for this?"

- Brenda D. - The meeting list itself, our RCM had submitted that the new Women's meeting is listed under Grand Island, instead of Hastings, NE. When you take this meeting list back, please let your Area's know that the meeting is in Hastings, not Grand Island.
