Treasurer's Report:

Greetings NRSCNA family,

I am submitting a written report this month, as I have several things to report. First and foremost, I made two errors in my report last month, which I noticed when I went to do the audit of last month's report yesterday. Both of these errors were to the good (in other words, we have more money than was reported last month), due to two things:

1. A refund check from Philadelphia Insurance Co. in the amount of \$189.00
2. A second donation from the Happy Havelock group of SENANA in the amount of \$76.00.

Both of these deposits were included in the bank deposit I made two days after Region (January 13). So all of the money donated or refunded has been both deposited and recorded. I apologize for not correcting this error sooner. I printed the erroneous report at last Region, but I did not get him a copy in time for the minutes. Secondly, I have received and deposited the donation check from ENNA for the Close Encounters area convention in the amount of \$1,793.58,. This amount will go on this quarters Region report, but the check is already in the bank. Despite this donation and the increased amount from the two corrections mentioned above, our ledger balance, not considering the other donations I will receive today, is \$3,863.60, below our \$4,320 prudent reserve. So that is something to consider as we are discussing business and ideas for projects in our meeting today. Thirdly, I received one request for the Insurance Policy from a person via email. It was my understanding from discussions at our last meeting that the policy was not to send this document to individuals outside of our meeting here, but that they could come to the RSC and view it. Otherwise, I will have to request it from the company, so I can have a copy on file for these requests.

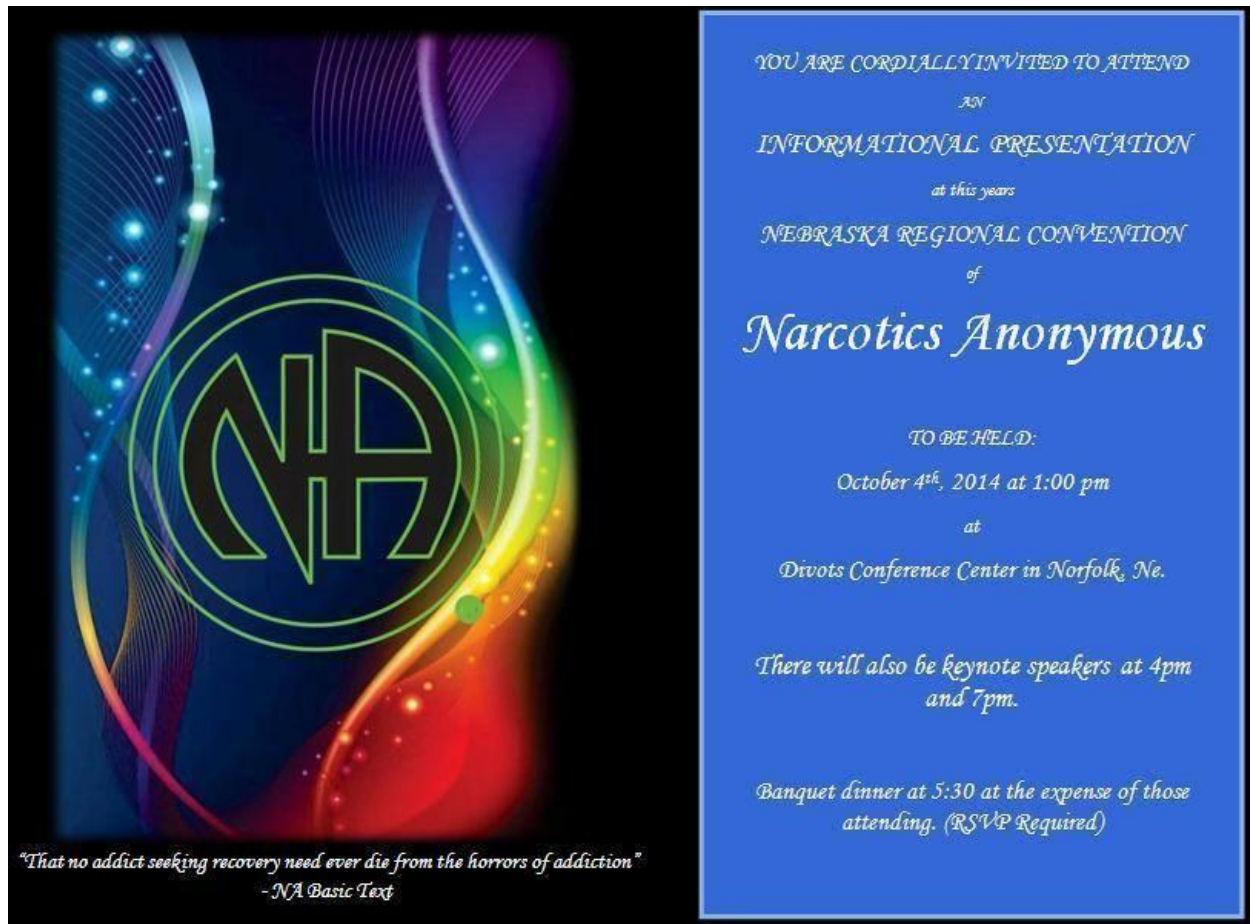
PI: Hello Family,
