Alt RD Report: Dear NA Family, Happy New Year! I'm truly excited for all the recovery we will get to see this year! Since last region, a lot has been happening! In November, we received the Conference Agenda Report (CAR). It contains a total of 16 motions for us to discuss and vote on and a survey that we encourage everyone to fill out before the April 1, 2020 deadline. (www.na.org/survey) I also attended the conference participant Zoom meeting on December 7th. During that meeting we discussed how to be an effective delegate and a few questions regarding the CAR. The CAT (Conference Approval Track) will be available in February. And for addicts like me who didn't know the difference, The CAR (Conference Agenda Report) focuses on the motions being voted on that give our World Services new direction, changes policy, approves fellowship literature, and more. Motions in the CAR can only be voted on by Regional and Zonal Delegates. The CAT (Conference Approval Track) focuses on proposed project plans and budget for the next 2 years. Regional Delegates, Zonal Delegates, and World Board members all vote on proposals in the CAT.

In December, I sent out an input form (Thank you all for helping with this!!) to the RCM's to help gather information we will need to complete our Regional Report that we send into the WSC by February 15th. So, over the next few weeks, Brian and I will be compiling this information and submitting it. If I haven't received yours yet, please turn this into me during break or after the meeting today.

We also received the information on our registration and hotel information for the World Service Conference from April 25-May 3rd. The WSC will be in Woodland Hills CA and we found a good deal with round trip tickets for \$285 plus tax & fees (each). I started with a balance of \$1308.06 minus our Dallas flight \$260.20 (x2= \$520.40) with an ending balance of \$787.66.. We will be requesting our budgeted funds this quarter.

Your RD team will be going to Dallas for the Multi Zonal CAR/CAT January 24-26th. We will be attending our Zonal meeting in Glencoe, OK February 6th-9th. We were asked to hold a CAR workshop for the Fremont Freezeout on March 22nd and a SPAD workshop on the 21st. If your Area would like to host a CAR and/or CAT workshop, please contact Brian or I and we will be happy to help out! FYI... amendments to the CAR & CAT motions and regional responses to the CAR survey must be submitted by April 16th. Please let us know how you feel about these motions so we can carry your voice to the Conference.

Instead of listing everything in this report, I have handed out the Service Center Updates to all the RCM's... Please make copies for the GSR's to take back to the groups. (Or take a picture of it and email it to them) This contains all the information on the projects and workgroups for addicts to participate in if they want to. Another place they can get this information is of course on the na.org website, and now on the NA Meeting App! The new and improved NA app has a new menu interface, allowing for a more user-friendly functionality, a new button leading to surveys and other matters of interest to the NA Fellowship, ability to forward daily meditations via text or email, addition of main website meeting search as an option in Meeting Finder and buttons for NAWS News, NA Info, Contributions, Personal preferences, along with other minor cosmetic and functional changes. Once a year, in April, all groups not represented by an Area, but who are registered with World, will be sent an invitation and schedule of tentative dates and locations of the RSC meetings for the year. If such groups would like to receive minutes, they will notify us by mail. This will be the responsibility of each individual Area.
- 01/12/2019 Proposal #2 Add to guidelines: II. C. b. 4. Will supply Proposal Slips at each NRSC business meeting.
- 01/12/2019 Update Change numbering for Section VI. Resignation Or Removal Of Trusted Servants to Section VII to match the Table of Contents
- 04/13/2019 Update Remove from guidelines: Addendum B > Schedule Timeline for Nebraska Regional Guidelines > 2nd Quarter (April) *invitation to groups not represented by an area (see page 2 Secretary) This update was to maintain consistency with removal of information from II. C. b. 4.
- 10/12/2019 Proposal #2 Add to guidelines: MISCELLANEOUS d. d. Guidelines on Non-Fellowship Approved Literature

 the Nebraska Regional Meeting List. b) Revocation of Nebraska Regional Service Committee website privileges. 2.
 Prior to removal from meeting list and/or revocation of website privileges, the following steps should be taken: a)
 Member concerns are presented at Regional Business Meeting. b) Regional Delegate and another member of the
 executive committee should follow-up on presented concerns with group/meeting at their group business meeting
 for the purpose of communicating information contained in the Regional Policy. c) Following RD communication, the
 group/meeting will be given a period of 30 days to review Regional Policy information. After this period, if the
 group/meeting has chosen to continue to distribute and/or make available non-fellowship approved literature, the RD
 will then make a proposal to the RSC to enforce the current policy guidelines. After the review period stated in 2c.,
 the RSC may then decide if a cease and desist letter from the Narcotics Anonymous World Services is necessary.
- 10/12/19 Proposal #3 Add to guidelines: Replace Addendum D of Region Policies with the Draft NRCNA Guidelines and timelines prepared by the NRCNA Ad Hoc Committee.
- 10/12/19 Proposal #4 Add to guidelines: Miscellaneous e. (in addition to the existing guideline) e. ...every two weeks. The mail that is picked up will be sent by electronic means or regular mail to the appropriate committee member as determined by the RCM or person delegated.

General Discussion - Open Floor (4:10 PM)

- Sam S.: The southeast survivors area is done. Some of the individuals that were initially involved have left the state and there has been nobody to continue. The meetings that were a part of that Area are still meeting. There has been a number of new meetings that were created and some of them showed up to the SENANA meeting, wanting to be a part of the Area.
- Brian S.: We have an RD and RDA team that does not know how to get Area's to participate in the CAR and to get votes from Areas. We have had little participation for this. We have not had enough information to take back. What can we do to help get votes from Areas to take.
- Brenda D stated she would be happy to send out a flyer with information about what the car is, the current motions, and the upcoming trainings that are taking place.
- There is a Nebraska Delegate's News page on Facebook. If you are not on it, please get your name to Brenda D. so she can add you as a member. It is a private group and Brenda puts a lot of information on there for members.
- There could be a group that meets at the 2 PM sub-committee hour during the January Region that is taking place that could have more of a one-on-one interaction with the RCMs and the RD/ARD to present the information on current motions and topics that need addressed by the groups.
- As a trusted servant and RCM, we would have a decision to request trainings from the RD/ARD during the even years (October) time frame that would allow groups to be prepared for when the CAR comes out.

- Referring to the Conference Agenda Report, instead of just stating 'the CAR report' may be helpful in generating participation. Most people don't know what the CAR report is and won't ask when it goes above their head.
- The way this was brought to an that Area was to create excitement about the fact that this only happens every 2 years, that it is how we get to have a vote and say in what goes on and what literature comes out etc. It made people want to get involved.
- The Central Area stated that there were baby blue's in a detox facility that specified what group that they came from. Also, there was a sponsee that ended up with a step study guide that was provided to him by a group that was printed on it, from treatment.
- Approaching the facility and letting them know may be helpful in preventing unapproved literature from being spread throughout the facilities.
- We've talked in our area about approaching the facilities. The facility may not want to be involved in any of it and request that both parties not bring anything or be welcome. Some opinions as far as, treatment or detox centers go, we are not sure what to do.
- Another solution is that we have built a rapport with the contact person in the facility. It is helpful to be able to speak to that person and let them know about unapproved literature. Obviously not every employee is going to know however, having their assistance in monitoring this can be helpful.
- If we want good literature to go out instead of bad literature, we need to make sure that facilities have access to our literature and information.
- A discussion was held on whether there should be a tally on every vote that is sent in, which would allow the RD and ARD to utilize that information to take to World. A vote was taken, which passed by consensus.
- Bids for the Next Convention Location are also still open.
- Although minutes were out below the 30 day timeline, the dates when the various Areas hold their business meetings don't allow for votes to get back to the groups in time. It is important that we have the meeting minutes out as soon as possible in order to allow all Areas and Groups to have a vote. According to policy, nominee's should submit a bio before they leave Region. This would solve the issue with this specific scenario, not having bios submitted to send out minutes.
- The annual budget for Policy is \$50.00. Since there is nothing in print at this time, it was proposed to have the \$50.00 removed from the policy. It was stated that if in the future, this would be needed, it would be wise to have in place. If the amount is not needed, do not accept the funds.
