We attended the Conference Participants webinar on June 27th. During that meeting we discussed what the 2nd half of the virtual World Service Conference 2020 would look like. The 2nd half will be convening on August 7-9, 2020 and if all business is not completed by then, August 28 – 30, 2020. Consensus e-polls were taken, and we will be discussing 13 of the 34 motions. The rest of the motions will be decided in 2022. Also, there is a survey out on the

na.org page. This survey was created by researchers and we are pleased to be able to cooperate with them in the hopes of furthering our primary purpose. Please consider participating.

- There is a new scientific study published about Narcotics Anonymous, called "We Do Recover". It was authored by four prestigious researchers and has a lot of good information in it to utilize in PR presentations and any fellowship development committees. Formal scientific studies of NA first appeared in the 1950s and early 1960s. Rigorous studies of NA began in the 1980s. If you would like more information, I would be happy to email that out to you.
- Plains States Zonal Forum will be meeting virtually on July 18th at 3pm. This meeting will meet on zoom (mtg id is 921 626 3087) Everyone is welcome to attend! We will be discussing budget and elections. Also, PSZF's 25th Anniversary is coming up! We were formed at the WSC in 1995 and our first meeting was September 23, 1995!

- The hotel is only allowed to be at 50% capacity. This means that only 150 people would be allowed in the conference room for main events, while smaller rooms would only be allowed 8 people, including the hospitality room. Social distancing guidelines of 8 six feet apart would be required, making requirements for seating to be arranged in a theatre style. The NRCNA 37 committee has come to a decision that they would like to reschedule the convention for October 1-3rd of 2021. The hotel has the dates available and would allow the same contract to be kept, as well as anyone who has booked a room would be able to roll over with the new dates or their money can be refunded. The contract will be included with the minutes. These are extenuating circumstances. Discussion is likely to follow at October Region, however, this needs to go back to groups for a vote.
