General Assembly: Approximately 25 attendees. Brian S began with a quick workshop on CBDM procedures so everyone present would understand the concept. Diane K provided copies of CBDM Policies from 3 other Midwest Regions. We broke up into 5 separate workgroups to determine what to recommend to the NRSC. There was unanimous consensus on the following recommendations for CBDM parameters to be included in the Policies:

- 1. Any member attending the NRSC meeting may participate in the discussion.
- 2. There will be no required Quorum in order to conduct business. RCM's are responsible for either having a proxy present or arranging to be present using technology such as facetime or teleconference.
- 3. Any member may make a proposal, but it must be co-sponsored by an RCM, Office, Committee Chair, or RD/ARD
- 4. Voting membership: for proposals needing a group vote (i.e. financial, policy change etc) only RCM's may vote on straw polls and final pools for proposals on internal issues (i.e. where to hold the next RSC etc) RCM's, Officers, RD/RDA, and Committee Chairs may vote on straw polls and final polls.
- 5. On all proposal, consensus will be reached by "unanimous minus 2" (For example: if there are 8 RCM's eligible to vote, at least 6 must be in favor of the proposal to have consenus.) keep in mind, that if the proposal can not be developed into an idea that works for the majority through discussion and input by all then perhaps it needs to be tabled or withdrawn.
- 6. We recommend use of the 3 card system currently being used in the Central Area: red, green and white. Based on the Iowa guidelines and that we incorporate these recommendations into a format that will serve the NRSC Policies. Diane K.

H & I: Hello family, H&I is going strong in our Region. 5 Areas represented at the meeting and we had 36 facilities reported for H&I commitments. Great Plains jail meeting in Kearney is struggling with volunteers to go in. Motion 3: One-Time payments of \$100 for a year subscription to QuickBooks online. Financial Impact: \$100

Intent: To ease the burden on treasurer by allowing finances to be managed by a cloud service that does not require a laptop and a printer to be hauled to Region (PDF reports can be generated and emailed to everyone, including the secretary), as it can be done on a cellphone or tablet. This decreases the technology, physicality and financial burden on the treasurer. It also increases transparency by allowing a hosted service to track our finances, to which other committee members can log in and bank reconciliation can be done automatically from any cell phone. General Discussion: Diane K discussed the policy changes from January 2014 and any changes that have been made since that date. For the purpose of having a working document for CBDM guidelines. Looking at the policy, she observed that the format "sucks". Re-formatting would make locating items within the Policy easier. This would include sections, sub-sections etc. Also, can we incorporate some type of working document so that by next Region there is an updated Policy to vote on. If the document is finished before next Region can it be posted on the website? Yes. Sam stated that a page for Policy can be created. Brian suggested that more time be placed on the guidelines before anything is submitted. If we did review it as we write it then input can be given at each step. Chad did not like waiting until next Region because of the amount of time that lapses between each Regional meeting. Kim liked having it go out to Areas because then Areas can contribute as well. Diane reiterated that she would not be making any changes to policy, rather re-formatting what is already written. Proposal passed by consensus for Policy Re-Formatting. Amber shared with the group that she is expecting a child in June and would like help covering for her expected absence at the July Regional meeting. Chad stated that his Area places the responsibility on their Vice-Chair. Kendra D volunteered to proxy for the secretarial position in July. Thank you Kendra! Sam discussed his concerns with the Region's Website and linking other Region's website and events links with ours. Could a page be devoted solely to events happening outside of Nebraska? NA.org serves the purpose of containing all that information. A link can be placed to direct people Proposal passed by consensus to extend General Discussion. Chad asked what is the time-frame for the minutes to be distributed? There is nothing stated in policy.

Proposal 2: For North Platte to host the April NRSC business meeting at the Masonic Lodge. Submitted by Deborah T. 2nd Mark W Intent: To allow Great Plains Area to have a fundraiser for NRCNA **Proposal Passed by consensus**

Proposal 3: Fremont would like to host Region on April 8th 2017 at the Berean Church 3rd & C St. Fremont NE Submitted by Gaylan S 2nd Travis W Intent: NRCNA 34 fundraiser to follow! **Proposal did not pass.**

Proposal 4: Change Policy – Bullet 2 under Subcommittees to read "Chairperson for the subcommittee will be two-year term and clean time requirement of 18 months, with the exception of the Convention Chair, which will have a term from the time they are elected thru the January RSC following the convention they are chairing (typically 2 years, 3 months). Clean time requirement for Convention Chair is 5 years.

Intent: Our Region often has to waive clean time requirements to allow election of a qualified member to chair a sub-committee. Secondly, the convention chair position obviously lasts longer than 1 year, according to our Policy Timelines and Convention Guidelines. When the

Convention Guidelines were developed 5 years' clean time was recommended and approved by the Region; however, the main Policy was never adjusted.
