RD Report: Greetings NA family, II'm grateful to see you all today... Lots has been happening, so let's just dig right in... I attended the Interim Virtual World Service Conference at the end of April. Recap – all motions passed and we have a new book!! Spiritual Principle a Day should be out later this year in print.. until then, you can sign up for a daily email (like Just For Today) at na.org/subscribe. And just a reminder, this is now fellowship approved literature and can be utilized at meetings. Also, they are starting discussions on the Future of the WSC. It seems there will be motions submitted this fall to change the cycle from 2 years to 3 years on a trial basis for the next 2 cycles. This is something that will affect this region as far as term limits for delegate team and their budget. I would appreciate any feed back about this! The two letters of recommendation can be found at the na.org website or I have hardcopies here. Plains States Zonal Forum was in South Dakota in May. New trusted servants stepped into positions.. Facilitator – Barry B, Co-Facilitator – Beth N., Secretary – Tonya, Treasurer – Natalie IT – intent to fill, SBTW – Sam, PR – Sally R nominated. We had a great PR presentation from the NEZF (North East Zonal Forum) with lots of great ideas and information. We had a SBTW training and they could really use addicts to step up and get trained.. letters are starting to come in. They also could use new volunteers to step up into their workgroup positions. There is also an informational zoom meeting tomorrow (Sunday July 10) from 2pm – 7pm to discuss the Collaboration of US Zones (something similar to APF or EDM). If anyone is interested, please see me after the meeting today and I will get you the information. There is a YAP# available on the PSZF webpage... so please keep those meeting lists current! Those changes electronically are effective immediately. Next meeting is August 2022. The June Conference Participant's Webinar started the conversations about the Board recommendation on trying two 3-year cycles with an interim meeting between in-person meetings. They asked us 3 questions... 1) What are your thoughts on the overall approach laid out in the report? 2) Do you have any ideas to share about vetting CAR motions or other ways to improve collaboration on the CAR? 3) How can we make the planning process more robust and inclusive? We also received a financial update in June (Keeping their commitment to provide CP's with a financial update every two months) One of those updates was about a 12% increase in literature orders effective January 2023. COLUMBUS reported they are going into Platte County jail twice a month for men. They do not have any females approved or interested at this time. They are trying to get into Butler County, as well. SOS panel every 4th Tuesday of the month.

GREAT PLAINS are having panels once a week for both men and women at Lincoln County Jail. Buttalo county jail is still on lockdown and have changed their requirements from 3 yrs to 2 yrs clean time requirement.

SENNA is back in Lancaster County jail for men only. They still need females to get approved and waiting to do service. No NSP at this time and still on lockdown. They will be having an H & I training day w/ a Cornhole Tourney on 7/23.

CENTRAL panels are going into St. Francis, mostly by ZOOM, four times a month. They are struggling with people wanting to commit. A training day was held June 25th and 9 were trained and 5 recertified. Hall Co. Corrections is still in lockdown, and detox as well.
