I am happy to report that with a very successful fundraiser, the \$3,000.00 needed to put the message on one bus for one year was reached. The message of recovery is now cruising the streets of Lincoln. At the last regional meeting I was asked about whether our area was going to put out a proposal for regional help with this effort. Since the fundraiser had not been held yet, I was unsure what to do. I would like to have Chris H submit a topic on open floor about this because we would like to be able to gauge interest from other areas in our region. Sunday Night Solutions indicates that, at least for now, their goal to get the message on a city bus has been met and the idea can be taken over by our PR committee for future buses/years. They are, however, very willing to answer any questions that anyone has regarding what it took to put the message on a Lincoln city bus.

RD Report:

Brenda D: RD Report NRSC April 2023

Hello NA Family,
Conference season is in full swing! We held workshops in 4 Areas and had the motions available on the Nebraska website for anyone not able to attend a workshop. We have the results of these for you and

will be taking them to the World Service Conference at the end of the month. We will be asking for a vote of confidence for your delegate team during this business meeting... Can we please add that to the agenda today?

We made a little history in February here in Nebraska... we hosted the very first service collaboration of all the zones in the US. We went over the Conference Agenda Report and the Conference Approval Track, and had most of the motion makers from the Regions in attendance to personally present their motions and answer any questions. I think Tommy has more on that... we decided to split up the tasks of reporting...

The 2022 Annual Report is out and available online at www.na.or/AR ... This goes over all the details of what has been going on this last fiscal year. It is published as an interactive electronic document and also posted in PDF format.

We attended the Conference Participants meeting in March. During that meeting we discussed WSC topics and logistics. This will be our first truly hybrid WSC. We currently have 14 participants planning to attend virtually and 18 more who are uncertain if they will be able to obtain visas. This means we can't approach the conference the same way we have in the past. Our biggest challenge will be me. There will not be paper handouts or notebooks, as had been given out in prior conferences. Instead, there will be an online conference portal for both in-person and online participants to access resources. Delegates will need to bring a connected device (Tablet or computer) for the WSC. Masks will be required, and we will be testing for Covid the day before we travel, as well as the first and third days of the conference. All meetings will be scheduled during the day all week to accommodate the virtual participants. There will not be any day off during the conference as during prior years. Tommy and I coordinated our flights with the Iowa delegates. We are leaving Omaha on the 28th and coming back on May 7th. We got our flights round trip for \$312.56 + taxes and fees each. (\$365.80 /each plus \$30 for 1st checked bag, \$40 for 2nd checked bag)

On April 1st we attended the Conference Participant meeting to discuss any questions we had plus go over orientation and processes for business. There is a new discussion board for delegates to ask questions or to share suggestions. The Amendments for the current motions have a deadline of April 15th and after that an e-poll will be sent to all voting participants and a straw poll will be taken at that time. We will only have 72 hours to respond, so we would like some direction from this body on a couple of the motions. The margin is very slim... so if we could please add that to the agenda today? It shouldn't take long to go through..

There is a WSC Unity Day flyer attached to this report. It is for Saturday April 29th. There will be a speaker meeting at 7:30 pm and the meeting id and password are on it if anyone wants to jump on. Those times are all Pacific Time so we are 2 hours ahead of them (9:30pm CST).

Annual Events coming up are Service Day on May 1st and PR week is the first full week in June.

The NA App now has the Spiritual Principle a day on it!

RDA Report:

Hello family!

Brenda and I decided to split responsibilities for this RSC meeting, so I will be reporting about what happened at the last Plain States Zonal Forum meeting held on February 5th. The PSZF meeting took place right after we hosted a CAR/CAT workshop with attendance from people all over the world, since it was a way to do something with the US Collaboration of Zones! I am humbled to have been able to help out a little with that process and I learned a ton.

At the PSZF meeting, we discussed the US Collaboration of Zones, which our zone has been involved with. The US Collaboration of Zones met on January 8th, with PSZF hosting the meeting. You might remember a while back there was a survey about the US Collaboration of Zones that regions were asked to complete. The PSZF is the only zone to have 100% of its regions complete the survey, so kudos to us. However, that means that there was not enough useful information to move forward with much, so the survey has been extended to this summer. Also at that meeting, the US Collaboration of Zones website was discussed, and a team formed to look into what should go on it and when it should go live. More will be revealed! The US Collaboration of Zones was scheduled to meet on April 2nd, so there is probably a bit more information available, but I do not have it.

If you are wondering about what the money we send to PSZF does, it goes towards efforts like SBTW, PR endeavors, hosting Zoom accounts that can be used by any NA group, area, or region in the Zone, among other things. All told, the budget for the PSZF is just over \$11,000 and the Nebraska Region contributed just over \$4,600 in 2022 after we decided to send 25% of what we have over prudent reserve to Zone!

The PSZF PR committee is busy with working on a project to get tablets with NA literature that can be given to incarcerated individuals in prisons. They also attend the NAWS PR webinars and discussions. Also in the works, is the creation of a Zonal trusted servant pool application process to help connect

people with skills to the service needs in the Zone.

There are lots of things coming up around our Zone. Later this month, April 21 st through 23 rd will be MARCNA in Wichita, KS. Also in the Mid America Region will be the 22 nd annual Recovery Feast June 2 nd - 4 th , and the 44 th annual Mid America Region Campout held June 30 th – July 2 nd . There will be a PSZF meeting July 28 th through 30 th held in Amarillo, TX and will include tons of service learning opportunities, including a PR event and other workshops. Iowa has been focusing on fellowship development efforts and have implemented a region-wide helpline using YAP. They are also working towards having an in-state service symposium. OK Region just finished their convention last weekend, but no worries, there is still the Clean and Crazy function June 16 th – 18 th at Lake Tenkiller and the Fall Spiritual Retreat in early November happening in Oklahoma. South Dakota will have their convention in Rapid City September 15 th -17 th . There will also be the Multi-Zonal Service Symposium held in Detroit, October 13 th -15 th (I know that is not in our Zone, but I wanted to mention it anyways).

Sponsorship Behind the Walls is still receiving letters from inmates in many prisons. There is need for trusted servants to help on this workgroup. One of those needs is to have a liaison from our region. I heard that our spectacular Vice-chair has stepped up to help until the position is filled. I know from experience that this is a great opportunity to get involved! There are also some workgroup positions open other than the liaison: CO-facilitator is open, Co-postal Coordinator is open, and must live in the Tulsa, OK vicinity, Co-Sponsor communications Coordinator is open.

I am super happy to report that Nebraska's very own P3 committee is revamping its communication efforts to get the word out to incarcerated folks about the ability to receive a free Basic Text. They are asking for areas to take information to inmates during H&I efforts. They also ask that if you know of jail staff who is very pro NA (friends of NA), please share P3 information with them. I have printed some flyers and information one pagers for RCMs to take and hopefully copy and distribute. Just some background, last year was a slow year for P3 and they still sent 216 Basic Texts. All together, they have sent more than 7500 Basic Texts to incarcerated people since 2006! I hope we can help to continue the good work they are doing!

We also discussed updating some Zonal guidelines updates and will be doing approval of those either at the Zonal meeting at the WSC or at the July meeting in Amarillo. Additionally, there was discussion about putting together an informational brochure about what PSZF does. Look for more on that in the future!

Other than that, we discussed a bit about what to expect at the WSC coming up at the end of April. I am excited to go and help represent the Nebraska Region with Brenda! I am sure to learn a ton and get a chance to carry our Region's voice. I want to say thank you to everyone who participated in CAR/CAT workshops and/or filled out the motion tally sheet and CAR Survey. I have also brought some printouts of the results of those tally sheets and surveys. I am sure there will be plenty of discussion about those today!

Finally, I just wanted to check in about financial stuff. I have paid for my airfare, which was \$365.80. I also reserved a rental vehicle, which will be split between the Nebraska and Iowa delegate teams. The total for the rental is \$761.29, including collision insurance. I have paid \$100 for the reservation so far. That works out to \$190.32 per person for an entire week of transportation (about \$27 per day). That is for a minivan, so there is the possibility of having other addicts join us on excursions and pitch in some to avoid high Uber fees. Anyways, that means that at the moment, I have \$2808.70 in the bank account. I will still need to pay for the hotel and food along with the rest of the rental car cost for the WSC.

Dear Family,

Barry B came and presented information on BMLT (Basic Meeting List Toolkit) YAP and Twilio how they work together for a statewide phone line.

The cost of a toll-free phone line is \$1.61 per month or a local number for \$.87 per month. Text messages would be extra, and the average cost is \$15 per month (\$180 / year or \$45/quarter).

Features that are available are volunteer lists, scheduling, adds and edits of members. A list of where the

calls are coming from and a chart to see how the phone is being used by flexible date searches. All the of features are adaptable to fit our needs. Other current phelines can be ported into this statewide number also.

Going forward, some things we would need to decide on would be:

1. Do we want a regional phone line?
2. Do we want a toll-free number or a local number?
3. Do we want the messaging feature enabled?
4. Do we want an option to transfer to a live addict?
5. If we want to transfer to a live addict, How long would the volunteer addict shift be?
6. Do we want to offer rides to meetings?

Please take this back to your Area's and discuss this to see what we would like to do going forward.

John H Senna RCM: Would like to gage the willingness of Nebraska Region to help fund a 2nd bus in Lincoln with our NA Message. Currently there is no way to track the effectiveness of the first bus. The cost is \$3,000 for 1 year for 1 bus.

Discussion and questions:

If we go to a statewide phone line could we update the phone number? Yes but remember all current numbers will continue to work as they will be ported over to the new phone system – when we are ready.

This is a great way to reach other addicts not just through H&I and the jail and this is a way to help the Region participate in reaching more addicts.

Tera N NRSC Treasurer: Rent for this facility for this month is \$145 as there is no function happening here to split the cost of rent with. Normally we only pay \$50 because an area holds a function, but that didn’t happen this time. Just as an FYI the rent for this facility is going up to \$200 starting next month. We will have a proposal to pay this rent in New Business.

Brenda D NRSC RD: I would like a vote of confidence to carry our votes regarding motions 14, 15, 16, 23, and 25. If you look at the results of all those that voted these motions are almost 50/50. We’d like to get the RCMs input.

Monic T NRSC Chair: The October region is schedule to happen during the NARCNA convention. Do we want to meet during the convention, or on a different date? This will be discussed in new business.

Dick T NRSC Archives: A bit of history. A while ago our website was hacked and the region lost access a bit to the website. After this incident we broke up the roles / duties of this and put the regional meeting list as a separate responsibility. Dick has been doing this commitment for 10 years and he'd like to pass on this duty to Tony S. Also would like to migrate off of 2 points of where the data is stored and only use the BMLT to store all meeting data.

Monica commented that Tony would also have the role to print the meeting directories each month.
