Greetings everyone!

I'm going to go ahead and share my screen if that's okay? I have some visuals to go along with my report so it should go quickly!

- First, I want to update you about the Environmental scan that we filled out at our last General Assembly. All the information has been gathered from all the participating regions around the world and now we will be meeting with the other regions in our Zone in April to discuss the survey results. We will be meeting on April 6th with Plains States Zonal Forum, Midwest Zonal Forum and the Southern Zonal Forum. Then Starting in May/June 2024, the planning process will begin and then we will start to prioritize those objectives.
- IDT's or Issue Discussion Topics are now available for you to workshop and give input on and learn from. These are all just discussions... talks and conversations that we want to have with you... no decisions are being made right now... we are simply asking how you feel about some of these things and getting new and fresh ideas from you. If your area or group would like to have one of these, please get ahold of Tommy or I and we will be happy to set something up with you!
- Next on my list of topics is the Survey for H&I that is posted out online. Has anyone done this yet? If you would like some support or want us to help facilitate it, Tommy or I would be happy to do this with you! WE hope that each H & I committee in Nebraska (Area & Region) will complete this survey... We believe we have a lot to offer!! The deadline for this survey is March 31, 2024.... There is also a bunch of information for Virtual Service Basics posted online, a PR Video, the New Group Booklet which is very cook and has CBDM updated in it.
- If you have members in your homegroups that like to volunteer their time, or are looking to expand their service efforts, there are opportunities to help with the work... they can fill out the Focus Group Form online and find it with the surveys
- Speaking of giving... I wanted to remind everyone of the free literature online.... The audio version of the basic text is available for free stream or download in NINE Languages.. so if you have some English is a second language addicts in your homegroups... this might be a place to point them...
- I have noticed that a lot of Nebraska counties are starting to get inmate tablets. Some correctional facilities offer inmates tablets pre-loaded with a variety of material, including, in some cases, NA recovery literature, at no cost to the inmate. One of the most important duties the Fellowship has assigned NA World Services is the protection of NA's intellectual property and copyrights on behalf of the Fellowship. Inmate tablets are a new way to carry the message, and World Services must grant legal permission to load Narcotics Anonymous literature on tablets. At this point, these agreements are all within the US, with a handful of state corrections, mental health, and youth service agencies, as well as a local county correctional agency. Each of these agreements involves a lot of communication among corrections authorities, local NA members, and NA World Services. The agreements we have made in these cases allow for the material that is currently posted on our website to be on tablets for inmates – audio Basic Texts, IPs, and booklets such as the White Booklet and the Intro Guide. This gives addicts ample exposure to NA and our message, and we continue to provide paper copies of the Basic Text to inmates upon request. There are over 3,000 counties in the US, and each agreement requires time and attention. World Services have also had inquiries from a couple of European communities and are in conversation about those possibilities as well. The number of inmate tablets with NA literature in Arizona rose to almost 50,000 in 2022. In Ohio, after seeing the success of inmate tablets, corrections officials have decided to purchase NA literature to give to inmates upon release. NA World Services devotes much of their time and energy to efforts such as these, not because it makes good business sense, but because we are driven by a spiritual mission, not a profit motive. If your Area PR would like to start the process of finding out how to get that literature on those tablets, Tommy and I would be happy to get you the contact information for our Zonal PR chair. They were just talking about this this last weekend.

There are some upcoming meetings and events folks might be interested in. There will be an IT work group meeting for the zone. This is yet to be scheduled, however, if you are interested in technology and/or service you can get involved. Talk to myself, Brenda, or (especially) Barry for more information and to be kept in the loop. The PSZF IT position is open, so this could be an opportunity to learn more about what that would entail. The PSZF PR committee meets on the 3 rd Tuesday of each month via Zoom. Those meetings are open to members who want to get involved in and/or learn more about Public Relations. The meeting information can be found at pszfna.org on the Zoom Calendar.

The next PSZF business meeting will be held virtually this Spring on a day/time TBD. Anyone is welcome to join and see what happens at zone! The next in-person zonal meeting will be July 19 th -21 st in Dodge City Kansas. The one after that will be in Oklahoma City, October 25 th - 27 th . There are always amazing workshops and fellowship along with the business meeting at the in-person meetings. The meeting last weekend was in Sioux City, IA, and included workshops on the IDT about gender neutral and inclusive language, reimagining and revitalizing service, H&I

in a virtual world, disruptive and predatory behavior, and the PSZF website and YAP. There is always a speaker and an

Some other meetings coming up are for the RD/RDA team, and I thought I would mention them here. The next Conference Participant Webinar is next weekend on January 20 th. There is a strategic planning meeting that will be held with NAWS staff and World Board members on April 6 th . Brenda and I will both be attending those to give input and get information to bring back here in April.

I also wanted to mention some of what the PSZF PR committee has been working on. They have been trying to figure out how to get NA literature into inmates in correctional facilities on tablets. There was a project being worked on to do this by directly working with the tablet manufacturer/suppliers. However, that is not working out the greatest because the vendors are wanting to make a profit off the literature. That will not work, so there is a refocus on making sure free literature can be used with existing tablets, and growing that program that is already happening. If you want to know more about that, please attend the PR meeting on the 3 rd Tuesday of each month on Zoom, as I mentioned earlier.

Some things going on in other regions in our zone:

In the Best Little Region, they extended their RD team terms to 3-years. They are also working with other regions in Texas to create a state-wide PR committee and website.

Oklahoma is having a General Service Assembly on February 5 th -7 th . Their regional convention will be April 12 th - 14 th , and the Clean and Crazy Campout will take place in June. Also in Oklahoma, they decided to fund RCMs to go to in-person PSZF meetings. Two out of their 3 RCMs attended the meeting in Sioux City with much positive feedback. Another cool thing they did was create key tags with QR codes that link to their website.

Mid America Region in Kansas is also having a service symposium event on June 15 th in Marquette, KS. There will be tons of cool service workshops. (Also, there is a great motorcycle museum in Marquette.) MARCNA will be April 26 th - 28 th in Wichita, the Mid America Campout is July 4 th - 7 th , and Soul 2 Soul will be held in October.

A couple of important things that came out of the zonal meeting need to be mentioned here too.

There was a decision made to purchase an Owl camera/microphone setup for use in virtual meetings. We were able to use one that was supplied by the meeting facility, and it was wonderful. This unit costs about \$1,000. There is also going to be exploration about web server options to be discussed at the meeting this Spring. Currently, PSZF hosts a ton of services, including the BLMT (Basic Meeting List Tool), etc. It will be important to have the capability to do that without service outages, which we have been able to do with our current provider. It is also prudent to look around and see if there are more cost-effective ways to do so. More will be revealed.

I have sent the PSZF treasurer report to Kora to send out with the minutes, because I know there are many members who want to know what our donations do. Some of the things include maintaining multiple Zoom accounts that any group, area, or region in our Zone can use at no cost. Additionally, YAP is available to help with helplines, and coordination of service efforts take place. There is more, but those are a few things. To get involved with service, there is a human resources pool you can fill out on pszfna.org. This pool will help the zone and regions identify people with skills to help with projects, while not having to hold a position necessarily.

There is also a proposed budget change for PSZF to adjust for the 3-year cycle for our meetings. I have included the proposed budget at the bottom of this report. I will be making a proposal to accept this budget during new business. This will need to go back to groups because PSZF is accountable to all the groups in the zone.

Finally, I spent a little money going to Sioux City for gas and a hotel room. Below is my financial transactions.
